



2022 International Conference on Business Enabling Environment – Transition to the new BEE project

1. Background

Since its selection as a champion economy in Enforcing Contracts from APEC Summit in 2009, Korea has worked with diverse APEC member nations to improve their legal regimes.

Korea has discussed many issues concerning Getting Credit, Protecting Minority Investors, Enforcing Contracts and Resolving Insolvency indicators with APEC member nations and its partner economies, hosted international seminars and conferences annually to share knowledge and expertise with the participants, and contributed to the enhancement of their countries' legal systems.
