To conduct PEMUDAH Meetings as continuous effort by MPC to assess the quality of existing regulations and identify unnecessary regulatory burden on businesses.</li> </ul> <p><b>Background</b></p> <p>In line with the government's initiative to ease regulatory burdens on businesses, the Special Task Force to Facilitate Business (PEMUDAH) was established on 7 February 2007 with the aim of addressing bureaucratic complexities and improving the quality of business regulations to boost Malaysia's productivity, competitiveness and economic growth. PEMUDAH plays a crucial role in streamlining regulations and fostering a more business-friendly environment in Malaysia.</p> <p>Reporting directly to the Prime Minister, the team comprises of highly respected individuals from both the private and public sectors. PEMUDAH co-chairs by Chief Secretary to the Government of Malaysia and Captain of Industry.</p> <p>Under PEMUDAH, there are 10 Technical Working Groups covering specific areas of doing business. In addition, PEMUDAH also supports a new corporate flagship, Business Ready (B-READY), which replaces the Doing Business Report. It assesses the global business and investment environment annually, along with other competitiveness reports such as the World Competitiveness Ranking (WCR) and the latest report by WEF, Future of Growth.</p>


