The Covid-19 pandemic has shown how critical it is, revealing significant gaps and inequalities that hinder economic growth and worsen social disparities. As the world recovers, it is crucial to address gender inequalities, reform economic policies, and tackle challenges in this sector. This includes increasing women's participation in the workforce, professionalizing care work, and recognizing the benefits of investing in care services.</p> <p>In Malaysia, the demand for comprehensive health and social care services is rising due to an aging population, growing autism cases, and decreasing female workforce participation. To create a fair and sustainable care economy, proactive steps are being taken, such as developing a Care Industry Action Plan and supporting investments in the care economy.</p> <p>The growing importance of the care industry is reflected in increased engagement from stakeholders. The first Malaysia Care Economy Forum (MCEF) in 2023 brought together diverse stakeholders to develop policy recommendations for a resilient care economy. Key recommendations included promoting professionalism and certification in the care sector, recognizing the leadership skills gained from care work, and ensuring attention to different types of care.</p> <p>Building on the recommendations from the 2023 MCEF, this year's forum, "Caregiving in a Caring Society" (MCEF 2.0), aims to provide actionable advice on professionalizing care workers and improving access to care. The goal is to make quality care services more accessible, enhance the reputation of care work, and create better career opportunities for care providers. Professionalizing care work is essential for the growth</p>

	<p>of Malaysia's care economy and highlights the important role care workers play in supporting individuals, families, and communities.</p>

These efforts are crucial for enhancing the quality-of-care services and providing well-deserved recognition to the vital role care workers play in society.</p> <p>Additionally, with an aging population and increasing special care needs, coupled with the declining participation of women in the workforce, this project proactively addresses pressing social and economic issues in Malaysia. The outcomes from this forum will lay the foundation for the necessary policy reforms to ensure better access to quality care services.</p> <p>This conference will bring together industry players and MPC officers via Technical Working Group on Sustainable Development Goals (TWGSDG) and Private Healthcare Productivity Nexus (PHPN) to exchange knowledge and explore innovative solutions within the care economy, aiming to boost productivity and drive advancements in caregiving practices and services.</p>
