From 12 - 19 November 2025, the Port of Antwerp-Bruges, in collaboration with APEC (the international training centre of the Flemish ports), will host a tailor-made port course in Antwerp, Belgium. The seminar aims to attract participants from the shipping, forwarding, and wider port logistics community.

2. The focus of the programme varies each year. According to the attached document, this year's edition will cover the competitive advantages of the Port of Antwerp-Bruges and Zeebrugge Port, with emphasis on among others; digitalisation, connectivity, and the energy transition.

3. For your information, Malaysia has actively participated in this programme over the past three years. In 2023, two sessions were attended by Malaysian representatives (six in one session and three in another) from government agencies, port authorities, and logistics companies. These were coordinated by SSDD through MPC's Logistics Nexus Cluster.

4. In this regard, APEC has sought MITI Brussels' assistance to extend the invitation to potential participants in Malaysia. APEC has also confirmed that **three (3) scholarships** will be offered to Malaysian participants, covering:

- Registration fee of the course
- Training materials
- Hotel accommodation (including breakfasts and dinners)
- Local transportation during the programme
- Lunches
- Insurance

Please note that international flights and airport–hotel transfers are not included.

5. We would be grateful if SSDD could kindly:

- share this invitation with the relevant industry associations and players in Malaysia;
- coordinate Malaysia's participation; and
- nominate three candidates for the scholarships.
