# FORMAT GUIDELINE

1. **Font type:** Arial Narrow; **Font size:** 12
2. **Line spacing:** 1.15; **Double line spacing** between sections
3. **Headings**
  - First-level heading** (Font size 16): All letters in **UPPER CASE** and in **bold**
  - Second-level heading** (Font size 14): All letters in **UPPER CASE** and in **bold**
  - Third-level heading** (Font size 14): **Capitalise** each word and in **bold**

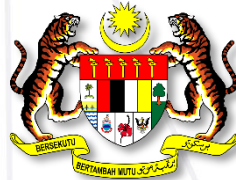
