Any terms and conditions which is illegal, void, prohibited or unenforceable shall be ineffective to the extent of such illegality, void, prohibition or unenforceability without invalidating the remaining provisions hereof. No delay in exercising or non-exercise by either party of any of its rights under or in connection with the terms and conditions of this Sponsorship Agreement shall operate as a waiver or release of that right. Rather, any such waiver or release must be specifically granted in writing signed by the party granting it. The waiver of either part of any of the terms and conditions of this Sponsorship Agreement shall not prejudice any remedy to or insistence of strict rights for the waiving party in respect of other breaches of the same or other terms and conditions hereunder. Unless otherwise agreed to in writing by the parties, neither party shall assign or transfer all or any of its rights, obligations or benefits hereunder to any third party.

	<p>f. Each party will bear its own legal costs and expenses in relation to the negotiation, preparation and execution of this Sponsorship agreement and other documents relating or ancillary to it. The stamp duty payable under this Sponsorship Agreement shall be borne by the Organiser.</p> <p>g. Where any dispute arises in relation to the terms and conditions of this Sponsorship Agreement, both parties will make genuine efforts to resolve the dispute by negotiation between them (ensuring the dispute is internally escalated to the appropriate levels of management as required). If negotiation fails, the parties will finally resolve the dispute in the Courts of Malaysia.</p> <p>h. The terms and conditions of this Sponsorship Agreement shall be governed by the laws of Malaysia.</p>
10	<p>Anti-Corruption</p> <p>10.1 The Organiser shall, in performing its contractual obligations to PayNet pursuant to this Agreement:</p> <ul style="list-style-type: none"> (a) act honestly and fairly; (b) provide PayNet with true and accurate information; (c) strictly comply with all relevant laws and regulations, including without limitation to those relating to anti-corruption, namely the MACC Act and all relevant Guidelines, circulars or directives; (d) comply with PayNet's position on anti-corruption, along with any guidelines on ethics and integrity communicated by PayNet and made available in PayNet's official website; (e) not: <ul style="list-style-type: none"> (1) directly or indirectly offer or provide to an employee, director or other representative of PayNet; or (2) directly or indirectly solicit or accept from an employee, director or other representative of PayNet, <p>any gratification, as inducement to or reward for:</p> <ul style="list-style-type: none"> (A) improperly influencing a business decision to act contrary to PayNet's interest or for the purpose of obtaining any advantage in the implementation of a contract; or (B) being improperly influenced in making a business decision to act contrary to PayNet's interest or for the purpose of conferring any undue or inappropriate advantage in the implementation of a contract; <ul style="list-style-type: none"> (f) not offer or provide any gratification which might be considered a bribe under either local or international legislation to a government official, either in Malaysia or any other country; (g) not use improperly, for purposes of competition or personal gain, or pass on to others, any information which may be reasonably be regarded as confidential and is provided by PayNet as part of the business relationship, including plans, technical proposals and business details including information contained or transmitted electronically; (h) not give any gratification to a public official, in order to expedite a process in relation to work carried out for PayNet; (i) take all measures to prevent corrupt practices, unfair means and illegal activities at all

times while carrying out its contractual obligations;
(j) not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly with any employee or director of PayNet;
(k) ensure that its employees and other representatives of the Organiser dealing with PayNet are aware of the provisions above; and
(l) immediately notify PayNet in writing or orally, by informing any of the Designated Officer of PayNet as mentioned herein, if it is aware of any breach of this provision, or if it becomes reasonably suspicious that this provision may have been breached.

10.2 Where PayNet has reasonable concerns regarding behaviour involving gratification on the part of the Organiser, PayNet shall have the right to:

- (a) direct the Organiser to investigate the matter, and the Organiser shall carry out its investigations in the manner as directed by PayNet acting reasonably; and/or
- (b) conduct its own investigation into the matter, and the Organiser shall provide all reasonable assistance, information and documentation to PayNet, in respect of the conduct of investigations.

Pursuant to the investigation(s), if deemed necessary by PayNet, PayNet may acting reasonably require the Organiser to take such appropriate action(s) against any such person(s) involved in such corrupt behaviors.

10.3 Without prejudice to any other rights of PayNet, if the Organiser, its employee(s), director(s) or agent(s) is convicted by a court of law for corrupt practices, unfair means and illegal activities in relation to this Agreement, or any other agreement that the Organiser may have with PayNet, PayNet shall be entitled to terminate this Agreement at any time, by giving immediate written notice to that effect to the Organiser.

10.4 Notwithstanding any provision to the contrary, the Organiser shall be liable, without limitation, for all losses, costs, damages and expenses (including any incidental costs and expenses) incurred by the Organiser arising from termination under herein above.

10.5 For the avoidance of doubt, the parties hereby agree that the Organiser shall not be entitled to any claim from PayNet, any form of losses including loss of profit, damages, claims or other items whatsoever upon termination herein above.

10.6 For the purpose of this clause:

“Designated Officers of PayNet” means the following persons:

- a. Director of Internal Audit,
- b. Group Chief Executive Officer; or
- c. Chairman of Audit & Risk Committee.

“gratification” shall have the same meaning as in the MACC Act.

“Guidelines” means the Guidelines on Adequate Procedures pursuant to subsection (5) of section 17A under the MACC Act and such other guidelines, directives or regulations issued, amended and supplemented thereunder.
